Summer Soccer Competition

Terms and Conditions of Registration

General

1. The period of registration is until the last day of competition.
2. The competition registration system is Dribl and all account holders must comply with the terms and conditions of use and only utilise their own accounts.
3. The registrant, member, or guardian warrants that the information provided in their registration is current and correct.
4. SWSSS will require proof of identification prior to accepting a new registration.
5. Where the registrant is aged 18 years or over and is registering to work or volunteer in a role (e.g. coach/manager) with children under 18 years, they will be required to hold a current NSW Working with Children Check Number.
6. Registrants (or guardians) declare and warrant that they are medically, mentally and physically fit and able to participate in any football activity. They are not and must not be a danger to themselves or to the health and safety of others. They will immediately notify SWSSS in writing of any change to their medical condition, fitness and ability to participate. If feeling unwell they will not attend nor participate in any football activity.
7. All members or member's guardians, acknowledge and agree that a failure by the member and/or guardian to comply with the SWSSS Competition Rules and Code of Conduct may result in expulsion from the competition. A copy of the Competition Rules and the Code of Conduct is available as Terms and Conditions on each registration and on www.swsss.com.au.
8. The member (or guardian) will comply with smoking, vaping and alcohol bans at the hosting venue.
9. Members (and guardians) acknowledge and agree that any disciplinary decision or determination involving the member is accepted as final.
10. The member (or guardian) acknowledges and agrees that the liability for the payment of, or the entitlement to a refund of (as the case may be) the member's registration fee will be determined by SWSSS in accordance with the Competition Rules.
11. The member (or guardian) acknowledges that they are exposed to certain risks whilst participating in football including but not limited to physical exertion, contact with equipment and other persons, weather and ground conditions and exposure to

potential or actual medical conditions, infections and/or illnesses from communicable diseases (including, without limitation, COVID-19). They acknowledge that accidents can and often do happen which may result in them being injured or even killed, or their property being damaged. Members (or guardians) have voluntarily read and understood this warning and accept and assume the inherent risks in participating in football.

12. The member (or guardian) grant SWSSS and their staff and volunteers' permission to administer first aid to, and (if reasonably required) call an ambulance for them in the event of any personal injury during your participation in football and you undertake to pay or reimburse costs incurred for any such medical attention and ambulance transport.
13. Members (and guardians) will not make any statement in public, including on social media; that is disparaging or derogatory of a match official, opposition team or player, any official or administrator of the game.
14. Members (and guardians) will take due care of all equipment that is the property of the hosting venue.

Privacy and Personal Information

15. SWSSS will collect information about registrants in order to administer the competition appropriately through Dribl.
16. SWSSS will not disclose any personal information without the written consent of the registrant, member or member's guardian.
17. A registrant, member or guardian may request access to their personal information that SWSSS holds by sending an email admin@swsss.com.au.

Insurance, Indemnity, and Limitation of Liability

18. Personal Accident Insurance provides coverage for participants for injuries sustained while participating in the SWSSS competition activity.

20. To make a claim, email admin@swsss.com.au for instructions.
21. Members (and guardians) agree to indemnify, and will continue to indemnify, hold harmless and defend SWSSS (including each of their directors, officers, employees, agents, contractors and assigns) from and against all actions, proceedings, suits, claims, liabilities, damage, costs and expenses that may be incurred or sustained by each of them arising out of any person commencing any proceedings against them for any assault, negligence and/or breach of the Competition Rules, except to the extent that any liability, loss or damage is solely and directly caused by the wilful misconduct or negligence of those indemnified.
22. Members (and guardians) acknowledge that SWSSS will provide insurance to cover injuries sustained while participating in football and football related activities, subject to the scope and coverage as prescribed by SWSSS. A copy of the insurance policy will be available on www.swsss.com.au.

Members (or guardians) acknowledge that if they suffer any injury (including illness, disability or death) whilst participating in football activities and a cause of injury was the negligence, assault or breach of other obligations imposed by laws, then the liability SWSSS (including each of their directors, officers, employees, agents, contractors and assigns) is limited to the extent of any applicable insurance policy held by SWSSS and the amount which such insurer pays under the policy or applicable statutory insurance scheme.
24. Members (or guardians) acknowledge and agree that SWSSS is not liable to them for any loss or damage they suffer as a result of competitions or matches being cancelled, postponed or changed.

Use of Images

25. SWSSS may use your Image or in order to promote and market the competition.
26. SWSSS may capture a member's image obtained via use of a VEO system.
27. You consent to SWSSS and their representatives, agents and assigns using, recording, reproducing, publishing and broadcasting your image for the reasons described in clause 25, subject to the Member Protection Policy and local laws. Further, you forever discharge and release SWSSS from all liability related to the use of your Image in accordance with these Terms. Changes to these Terms

28. You acknowledge and agree that SWSSS may modify these terms from time to time by giving you advance notice and the opportunity to consent to any variation. SWSSS may seek to modify these terms to ensure they are reasonable and appropriate for the ongoing administration of the competition. Any notice under these terms may be provided to you via your nominated email.

Definitions

- Registrant:** the player or official registering in Dribl
- Member:** A registrant that has been approved by SWSSS in Dribl
- Guardian:** a person over the age of 18 that is legally responsible for the registrant or member that is registered in Dribl.
